Arabian Breeders World Cup Show Entry Agreement

AHBA ENTRY AGREEMENT —All entries are accepted with the understanding that the Arabian Horse Breeders Alliance will not be held responsible for any loss, damage or injury to any horse exhibited or any article. All horses shall be under the control and direction of the exhibitor, who will be responsible for any loss, damage or injury to any person, animals or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the Arabian Horse Breeders Alliance and the City of Scottsdale and the U.S. Bureau of Reclamation against any and all loss, damages, and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Exhibitors, grooms, handlers, owners, etc. are hereby warned that they may not use any device or conduct which may cause harm to any other person(s) horses, or equipment. THE SUBMISSION OF THIS ENTRY FORM SHALL CONSTITUTE ACCEPTANCE BY EACH PERSON TO THE RULES AND PROVISIONS SET FORTH BY THE ARABIAN HORSE BREEDERS ALLIANCE AND THE ARABIAN BREEDERS WORLD CUP HORSE SHOW.

FEDERATION ENTRY AGREEMENT - United States Equestrian Federation Release, Assumption of Risk, Waiver, and Indemnification By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the Scottsdale Arabian Horse Show (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State.
